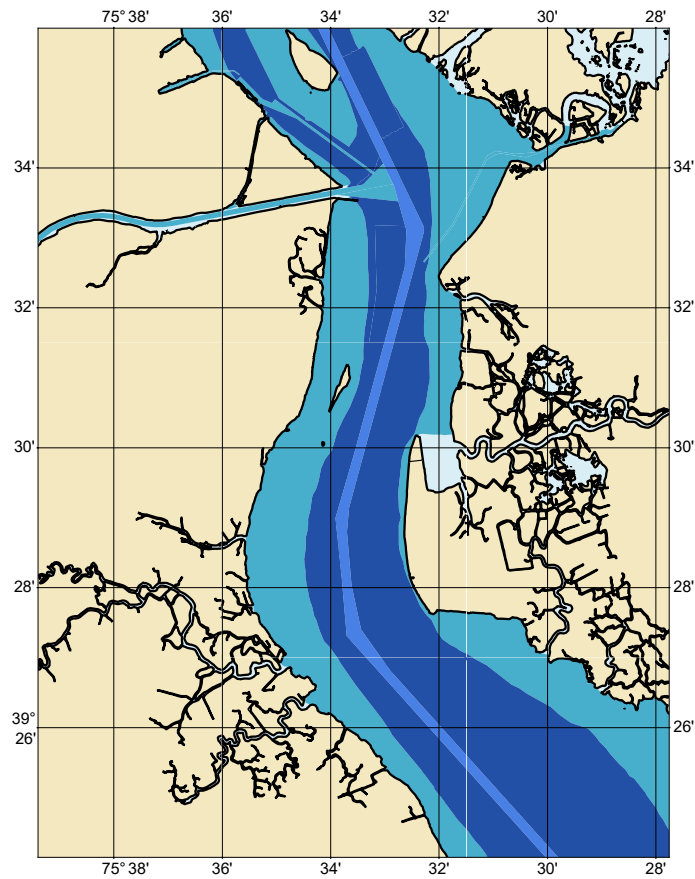


Zone of Confidence (ZOC) Diagram

CAUTION SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. Not all submarine pipelines and submarine cables are required to be buried, and those that were originally buried may have become exposed. Mariners should use extreme caution when operating vessels in depths of water comparable to their draft in areas where pipelines and cables may exist, and when anchoring, dragging or trawling.

Covered wells may be marked by lighted or unlighted buoys.

CAUTION

Improved channels are subject to shoaling, particularly at the edges.

PRIVATE CHANNELS

Bulkhead Shoal Channel, the turning basin and Cedar Creek Channel are projects of Star Enterprise Co. Aids to navigation are private.

WATER TURBULENCE

Mariners are advised to use particular caution in the Chesapeake and Delaware Canal and its approach via Elk River as far south as Turkey Point due to strong wakes and washes caused by large vessels. For additional information, see Chapter 7, U.S. Coast Pilot 3.

CAUTION OYSTER GROUNDS

Numerous stakes and obstructions exist within areas in Delaware Bay.

CAUTION

USACE conducts hydrographic surveys to monitor navigation conditions. These surveys are not intended to detect underwater features. CAUTION

During some winter months or when endangered by ice, certain aids to navigation are replaced by other types or removed. For details, see U.S. Coast Guard Light List.

Mariners are warned to stay clear of the protective riprap surrounding navigational light structures.

TRAFFIC LIGHTS

Traffic lights are in operation at Reedy Point Entrance and at Old Town Point Wharf.

AIDS TO NAVIGATION

Mercury vapor lights are located approximately 42.7 meters/140 feet from the edge of the channel. The lights in general are 152.4 meters/500 feet apart on both banks. Poles are 72.6 meters/250 feet apart; every other pole is lighted. The mercury vapor lights are maintained by the U.S. Army Corps of Engineers. These structures may have an overhead power cable connected them to the shore.

The NOAA Weather Radio station listed below provides continuous weather broadcasts. The reception range is typically 20 to 40 nautical miles from the antenna site, but can be as much as 100 nautical miles for stations at high elevations.

LOCAL MAGNETIC DISTURBANCE

Differences of as much as 2° to 5° from the normal variation have been observed along the channel from Artificial Island, New Jersey to Marcus Hook, Pennsylvania.
