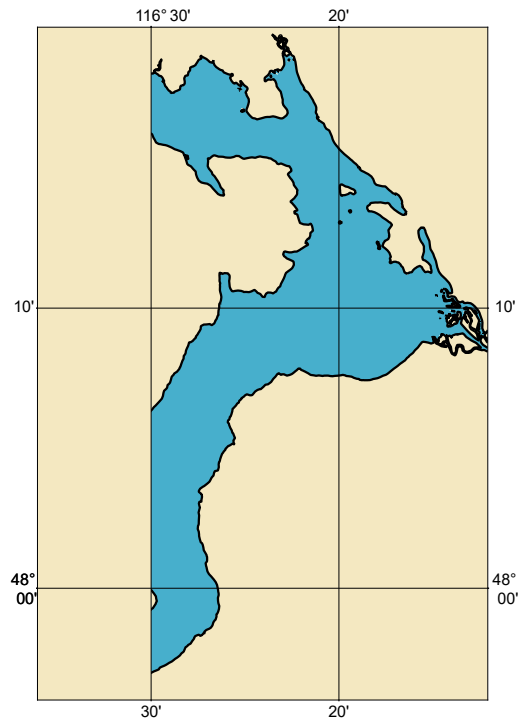


Zone of Confidence (ZOC) Diagram

SOUNDING DATUM

Soundings in Lake Pend Oreille are referred to a Lake Level of 2048.15 feet / 624.3 meters above Mean Sea Level.

NOTE A

CAUTION SUBMERGED CABLES AND PIPELINES

Additional uncharted submarine pipelines and submarine cables may exist within the area of this chart. Not all submarine pipelines and submarine cables are required to be buried, and those that were originally buried may have become exposed. Mariners should use extreme caution when operating vessels in depths of water comparable to their draft in areas where pipelines and cables may exist, and when anchoring, dragging or trawling.

Covered wells may be marked by lighted or unlighted buoys.

CAUTION

During periods of rising lake level, debris stranded on shore is floated and is present in large quantities in the lake. During this period, boats should proceed slowly and cautiously to avoid damage.

NOAA WEATHER RADIO BROADCASTS

CAUTION

A high voltage overhead power cable follows the shoreline in Oden Bay. This cable intermittently crosses over open water.

LAKE LEVEL

The normal winter lake level is 626.3 to 626.6 meters/2055 to 2056 feet above mean sea level which is 2.1 meters/7 feet above the datum of the soundings. The normal summer lake level is 628.5 to 628.6 meters/2062 to 2062.5 feet above mean sea level which is approximately 4.3 meters/14 feet above the datum of the soundings. The highest reported level of the lake is 632.7 meters/2076 feet above mean sea level which is approximately 8.5 meters/28 feet above the datum of the soundings. Daily corrected lake level information can be obtained from the Albeni Falls Dam power house control room by phoning 208-437-3133.

LOCAL MAGNETIC DISTURBANCE

Differences of as much as 3° from the normal variation may be expected within the limits of this chart.
